# APPLICATION FOR PLACEMENT OF BULK AND SKIP WASTE CONTAINERS

## GENERAL CONDITIONS OF PLACEMENT OF BULK AND SKIP WASTE CONTAINERS

1. Any Council consent for Placement of Bulk and Skip Waste Container(s) ("Consent") issued by Maitland City Council NSW ("Council"), shall comply with the General Conditions of Placement of Bulk and Skip Waste Containers, listed herein, except as modified by any Specific Conditions issued with the Notice of Consent.
2. The placement of Bulk and Skip Waste Containers (including skip bins) on Council's public roads shall be in accordance with the requirements of NSW Centre for Road Safety, Technical Direction, TD 2009 SR01 – Placement of Bulk and Skip Waste Containers except where the conditions herein depart from the said policy.
3. Queries regarding the placement of a bulk or skip waste container should be directed to Council's Traffic Management Section.
4. The party undertaking the work shall hold public liability insurance of not less \$20,000,000 and that the insurance policy is current. Council may require that the insurance policy includes Council listed as an Interested Party. A copy of the Certificate of Currency of the public liability insurance is to be lodged with Council before the Consent becomes effective.
5. Bulk and skip waste containers must not be delivered to either the road reserve or the property site prior to 7am Monday to Friday or prior to 8am Saturday. Containers must not be delivered to either the road reserve or the property site on a Sunday or a Public Holiday.
6. Food waste, dangerous or hazardous wastes shall not be placed in any bulk and skip waste containers.
7. Any damage to public property caused by bulk and skip waste containers is to be rectified at the expense of the applicant.
8. Council reserves the right to remove or order the removal of any bulk and skip waste containers despite any approval granted, if such container or the activity associated with it causes a nuisance.
9. Under an annual approval, bulk and skip waste containers can only be placed for a maximum period of 14 days (including any replacement skip bins). A separate individual application must be submitted to place a waste skip bin on Council land (in respect of the same property) for the period exceeding the initial 14 days.
10. The conditions and requirements specified in Council's approval must be complied with at all times. Failure to comply will result in the issue of a penalty notice or other regulatory actions.
