The Citizen of the Year Award is awarded to an individual for their contribution to the Maitland Local Government Area or broader society in a single year or across multiple years of service.
- ☐ **Young Citizen of the Year**
The Young Citizen of the Year Award is awarded to an individual for their contribution to the Maitland Local Government Area or the broader society in a single year or across multiple years.
- ☐ **City of Maitland Medal (Group or Organisation)**
The City of Maitland Medal is awarded to a Maitland focused organisation or group for outstanding voluntary service to Maitland and its citizens as a whole.
- ☐ **City of Maitland Service Award (Individual)**
The City of Maitland Service Award is awarded to an individual who has provided outstanding voluntary service to the Maitland community.
- ☐ **Sportsperson of the Year**
The Sportsperson of the Year Award recognises an individual for their significant achievement and contribution in a non-professional sporting field within the Maitland community for the previous 12 months.
- ☐ **Creative Arts Person of the Year**
The Creative Arts person of the Year recognises the creative expression of an individual through art, writing, music or movement within the Maitland community.

GENERAL INFORMATION

1. The Awards and Recognition Committee will be the judging panel and comprises the Mayor, four Councillors and two community representatives.
2. Should the Awards and Recognition Committee not receive any suitable nominations for the award categories, the Committee will be under no obligation to present an award for any, or all, categories.
3. The decision of the Awards and Recognition Committee is final and no correspondence will be entered into in respect to the decision.
4. The recipients of each award category will be announced and presented at the Australia Day function on 26 January each year.
5. Nominations will be called on an annual basis. Nominations must be completed using the nomination forms circulated by Council and must be submitted by the closing date.
6. An individual or an organisation may make nominations.

GENERAL INFORMATION CONTINUED

7. A maximum of one award per category will be awarded each year.
8. Please ensure you provide as much detail as possible to assist the Committee in making any decision on Award recipients.

ELIGIBILITY CRITERIA

To be eligible, nominees:

- Cannot nominate themselves.
- Cannot have previously received the same award.
- Cannot be a Maitland City Council employee or Councillor.
- Must be an Australian Citizen (Citizen of the Year and Young Citizen of the Year only).
- Must reside in the Maitland Local Government Area (Citizen of the Year and Young Citizen of the Year only).
- The Young Citizen of the Year is to be under the age of 25 years as at 26 January 2023 **in the awarding year**.
- The Sportsperson of the Year must be a non-professional sportsperson (someone who is not paid to compete in their chosen sport this includes not receiving a weekly or yearly salary. An individual who wins prize money on occasion for participating in sporting and championship events is not considered to be a paid sportsperson).
