Council has prepared a Planning Proposal to rezone land for large lot residential purposes at Dunmore Road, Largs

The purpose of the Planning Proposal is to amend the Maitland Local Environmental Plan 2011 (LEP) to rezone 9,240m² of land from RU2 Rural Landscape to R5 – Large Lot Residential. The Planning Proposal will facilitate the development of three (3) large residential lots, subject to a development application assessment.

The proposed rezoning is supported by site specific studies which have informed the developable area and subsequent proposed zone boundaries to respond to the constraints of the site.

Any future development of the land will require a development application and assessment against the provisions of the Maitland LEP 2011 and site-specific development controls.
